The Editor-in-chief is having sole right to publish this work in IJCMID journal
- 6. A self-attested certificate should be given by the applicant on a separate page about the Month & year of starting and end of work done.

- 2. He/she has attained the age of not more than 35 yrs as on 01.01.2024
- **3.** The last date for submission of application (both hard and soft copies) is 10.05.2024 (by 05:00 PM).
